1 What is Motorcyclist Personal Accident?

Motorcyclist Personal Accident is an optional add on under Motorcycle Policy. It provides compensation and reimbursement to the rider in the event of bodily injuries, disabilities or death caused solely by accident whilst boarding, riding or alighting from a private motorcycle.

2 Know Your Coverage

As an illustration, for **RM13** annually, a 30-year-old male purchases Plan MPA1 will receive the following coverage:

This policy **covers**:

- Accidental Death – **RM5,000**
- Permanent Disablement – **Up to RM5,000**
- Bereavement Allowance – **RM1,000**

This policy **excludes**:

- Racing (other than treasure hunts), rallies, pace making, speed testing, used in connection with motor trade, for hire or reward
- Vehicle used for carriage of passengers for reward
- Any act of terrorism

Note: This list is non-exhaustive. You should refer to the policy for the full list of exclusions under this policy.

The duration of coverage is 12 months. You need to renew your policy annually.

3 Know Your Obligations

For this personal accident add on, you must pay a premium of:	
Standard cover	RM13 (annually)
Additional Cover	-
Total premium you must pay is RM13	
You also have to pay the following fees and charges:	
Stamp duty	N/A
Commission (Only applies if the product is sold through an intermediary)	10% of premium or RM1.30
Service Tax	8% of premium or RM1.04

The applicability of stamp duty and service tax amount herein applied, or any other taxes are subjected to the prevailing laws of Malaysia.

4 Other Key Terms

- You must provide complete and accurate information in the application form.
 - You must disclose all material facts such as your occupation and personal pursuits.
 - **Age Limit:** All registered owners of a private motorcycle vehicle aged between 18 years to 75 years.
 - **Nominee:** You must nominate a nominee and to ensure that your nominee is aware of the personal accident policy.
 - **Claims:** You must submit your claim with all the supporting information and documents to us and give full cooperation to us in accessing your claim.
 - **Cash Before Cover:** Full premium must be paid to us or our authorized intermediary before the effective date of the policy.

? Can I cancel my policy?

- Yes. You may cancel your policy at any time by giving a written notice to us. Upon cancellation, we will return the proportionate part of the premium in respect of the unexpired period of insurance provided no claim has been made.
- If a claim has been approved before cancellation, no premium will be refunded.
